1. (a) All the Tenders must be addressed to

"Tender for Installation, operation and maintenance of Kurinji Canteen" located at the Railway Hospital Campus, Railway Colony, Madurai, including provision of Wicket Gate opposite to SBI - ATM near the main entrance for the entry to the canteen, up-keep maintenance of the Canteen premises, surrounding area demarcated with compound wall & fencing and required lighting arrangements".

- (b) Tenders received after 15.00hrs on <u>07.08.2024</u> will not be considered. SRWWO will not be liable for the delay in transmission through post and otherwise.
- 2. The tenderer must have a minimum of three years' experience in running Canteen or Hotel.
- 3. The tenderer must possess a Degree / Diploma in Hotel management or Catering.
- 4. Tenders may be submitted either in person or by Registered Post with acknowledgment. Tenders by Telegram, email, FAX and WhatsApp or any other electronic media will not be considered.
- 5. The Tender Rate/Offer shall be quoted in the BID FORM only, kept as Annexure I in the Tender Form.
- 6. The amount of Tender should be legibly written in Ink (or print out) in Figures and in Words. Any correction or alteration will be rejected.
- 7. No contract shall be awarded to a Minor under any circumstances.
- 8. Communication relating to the tender by the tenderer to the Society or any member of Society will not be entertained.
- 9. The Canteen shall be open on all 7 days of a week from 06.00hrs to 21.00hrs.
- 10. The period of contract is 3 years.
- 11. The building and the surrounding area provided with compound wall/fencing will be allotted.
- 12. SRWWO reserves the right to accept or reject any or every tender without assigning any reason.
- 13. The successful tenderer must deposit the License Fee in advance (Rent per month x Nine Months) to SRWWO along with caution deposit for electrical energy and water charges within 30 days from the date of receipt of "Letter of Acceptance" and shall execute an agreement in the prescribed form.
- 14. The successful tenderer has to set-up and start functioning of the canteen within one month of the issue of Letter of Acceptance. Failing which his/her Award/allotment may be cancelled.
- 15. The successful tenderer has to set-up all furniture both interior & exterior, accessories & vessels related to running the canteen, temporary aesthetic covering with lighting arrangements on the outer premises at their own cost. SRWWO will not pay or reimburse for any expenditure incurred to set-up and run the canteen.

- 16. The successful tenderer has to make the provision of Wicket Gate opposite to SBI ATM near the main entrance for the entry to the canteen duly dismantling the compound wall to the requirement at his/her own cost and SRWWO will not pay or reimburse for the expenditure incurred for providing wicket gate.
- 17. The successful tenderer shall bear the Electrical Charges and Water Charges with Deposit amount, if any, as per norms by the Railways.
- The successful tenderer shall sell Milk, Cool drinks (Non-alcoholic) beverages, confectionery items, cakes and packed foods admitted by Food safety and Standards Authority of India (FSSI).
- 19. Stale, spoiled, spurious or damaged food items shall not be sold at this canteen. If there is any complaint or people become sick consuming the food served by the Canteen, the contract shall be liable for termination and legal action. The contractor is completely liable to any consequences.
- 20. The successful tenderer shall prepare and sell the vegetarian items; Breakfast, Lunch, Dinner, Snacks, Tea, Coffee, tiffin duly maintaining high standard of food safety and Hygiene.
- 21. Selling Cigarettes, Gutkha, Pan masala or any drug related items is totally prohibited.
- 22. The successful tenderer is permitted to serve food within and outside the building in demarcated area.
- 23. The successful tenderer shall fix the price of items after getting the approval from SRWWO.
- 24. Any increase or decrease in price of any item shall be made to SRWWO for approval.
- 25. The successful tenderer shall comply with the requirements of the health standard of his/her personnel. If the person employed is found to be suffering from any infectious diseases as detected by SRWWO, the person will not be allowed to perform the duties till recovery from the disease as a precautionary and preventive measure.
- 26. SRWWO shall not be responsible or liable to pay any compensation or refund of License Fee to the successful tenderer, if the canteen does not function for any reason whatsoever.
- 27. All litigation, Legal cases and compensation thereof shall be taken care of by successful Tenderer. SRWWO shall not bear any expenditure arising out of any litigation, penalty or decree etc.,
